Local Trips

Our pupils regularly access the community as part of their day at School. This includes local trips to Balsall Common, Meriden, Kenilworth, Hampton-in-Arden, Kingsbury and Solihull. Some of our older children may go further afield to Star City Birmingham or Castle Vale.

Regular favourites are Barston Ford, Brueton Park and Meriden Woods, but trips are also made to other parks, fields, ponds, woods, zoos, the Airport, local shops and the library.

Risk Assessments are in place for all trips taken and for each individual pupil.

Swimming

At present, we are only able to provide very limited opportunities for swimming for our Post 14 children.

Any children who currently go swimming do so at local public baths. Our staff operate on a 1:1 pupil to tutor ratio in the pool but in many instances, additional staff will be required to support. Any access to swimming is therefore dependent upon staffing levels on any day. Obviously, the pools themselves provide lifeguards.

For those children who take part in swimming, please ensure that labelled swimming costume/trunks and towel are sent into School on the appropriate day.
